



SUMMER CAMP SCHOLARSHIP APPLICATION

A limited number of half summer (4 weeks) scholarships will be available to qualifying families. To qualify, you must be a Spartanburg County resident, the recipient of at least two forms of public assistance (acceptable forms are listed on page 2) and not owe any fees to Spartanburg Parks for past programs. Scholarships will cover the weekly camp fees for each session. Recipients will be required to pay a \$45 non-refundable deposit per child, per scholarship session. You may register your child for additional weeks (pending availability) at your expense.

Scholarships will be awarded through a random draw lottery system.

Letter of Recommendation

You are required to submit a letter of recommendation for your child that has been provided by your child’s teacher, principal, coach, pastor or other community member who has had an opportunity to know and work with your child. Scholarships will not be awarded unless this letter is provided.

Scholarship Agreement

- In order for scholarship recipients to retain or to qualify for future financial assistance, your child is expected to attend at least 75% of the time.
- Participants may be dismissed from summer camp and become ineligible for future scholarships due to excessive absences (over 25%)
- All scholarship recipients must follow current Camp Code of Conduct. Late withdrawals (less than one week prior to the start of camp) may result in your child becoming ineligible for future financial assistance.
